An apology from HARBORNE HARRIERS was announced regretting their inability to be represented owing to their Annual General Meeting taking place the same evening.

A report on the inauguration Meeting was made, and it was announced that since that Meeting "The Sunday Mercury & News" had very kindly offered to present a trophy to the League Champions.

It was decided after a long discussion that the name of the League be "THE BIRMINGHAM AND DISTRICT INVITATION CROSS COUNTRY LEAGUE".

It was proposed by MR.T.W.ADEY(Lozells H.) and seconded by MR.R.A.JAMES (Wednesbury H.) that SMALL HEATH HARRIERS be admitted to membership. It was felt that this addition would give us the help and experience of one of the oldest cross-country clubs.

The following resolutions were decided upon.

That HOME AND AWAY FIXTURES be arranged between each Club in membership. Any number of runners to compete.
The first SIX of each Club to count.
First claim-members only to compete.
Each club to hand the the League Secretary a list of its members prior to the first League race.

THAT the Management of the League be in the hands of TWO delegates from each Club.

That the "White Horse Hotel" be the HEADQUARTERS.

That the ANNUAL SUBSCRIPTION be 10/6d.per annum.

It was appreciated that the sum derived by this means would not be sufficient to meet the expenditure, and it was suggested that each Club in membership should devise a means of raising Funds for the League.

The question of a COMBINED OPENING RUN was deferred for the present season, but a suggestion was forthcoming to the effect that a Combined Run at the close of the season, following by tea and social and presentation of trophy and prizes, to be held at the Champion's headquarters, might be considered at the close of the 1925-6 season.

The distance of League races be not under five and not over seven miles.

THE BIRMINGHAM AND DISTRICT INVITATION CROSS-COUNTRY LEAGUE.

SUGGESTED
R U L E S

1. That the name of the League be "The Birmingham and District Invitation Cross-Country League".
2. That the objects of the League be the promotion of inter-Club contests between Clubs of supposed equal strength.
3. That the Management of the League in the President- to be selected from Seven Vice-Presidents (one from each Club) Two delegates from each Club, Hon. Treasurer, and Hon. Secretary.
4. That the Headquarters be the "White Horse Hotel"
5. Races to be confined to first-claim members.
6. The distance of Races to be not less than FIVE miles and not more than SEVEN miles.
7. Any number of runners may compete, the first six of each Club to count. Two points to count for a win and one for a draw.
8. League Champions to hold the "SUNDAY MERCURY" Shield, and winners and runners-up to receive medals.
9. A complete list of first claim members to be handed to the League Hon. Sec. prior to the commencement of each League programme, and notification of new members to be made as and when elected.
10. That Club subscription be 10/6d.

The total Subscriptions from League Members would Amount to £3.3.0. Added to this was a donation of £1.1.0 from Mr. J. Carson, the President of the Midland Counties Amateur Cross Country Assocⁿ.

Business Arising.

It was reported that the estimated cost of medals had been exceeded owing to the fact that the championship had resulted in a tie, necessitating two sets of Gold Medals being awarded.

Hon.Secretary's Report.

In his report, the Hon.Secretary stated that the tanks of of the League were due to "The Sunday Mercury and News" for the fine shield which they had put up for competition. The struggle for possession of the trophy for the first time had splendidly and sportingly fought out, and inasmuch that the result was not known until the final race had been decided, this was all to the good of the competition. The races had been well patronised, this being borne out by the fact that on Easter Saturday, no fewer than sixty athletes were present at the fixture between West Bromwich H. and Small Heath H. Prop. A.WROE, secd. W.F.WATSON, that report be adopted.

Hon.Treasurer's Report.

The Treasurer stated that owing to increase in medals, he was sorry to report and adverse balance of 25.12. 0. Medals had cost 210.4. 0., individual prize 25/-, engraving of shield 4/-, postage, telegrams, and stationery 27/-, making a total of 215.0. 6. Club subscriptions had amounted to 25.3.0., donation by Mr.J.Carson 21/- and Club collecting cards 23.4.6. It was stated that several cards were still out, and it was hoped that every endeavour would be made to wipe out the deficit prior to the opening of the ensuing season. Prop. R.S.ANGELL, secd. T.W.ADEY that report be adopted.
